1325 and Beyond Essay Competition – WIIS & Heinrich Böll Stiftung

Deadline: April 15, 2020

Description:

In the run up to the 20th anniversary of the United Nations Security Council Resolution 1325 (UNSCR 1325 (2000)) Women In International Security (WIIS) and the Heinrich Böll Foundation Washington, DC are launching an international graduate student essay competition 1325AndBeyond.

The essay contest is intended to highlight innovative and imaginative ideas and strategies to achieve the objectives of 1325 in the 2020s. We hope they will provide important input for the 20th anniversary deliberations of UNSCR 1325.

The 1325AndBeyond competition aims to highlight innovative and imaginative strategies to achieve the objectives of 1325 in the next decade—the 2020s. The top five essays will be recognized and will receive a monetary award.

First place winner \$1,325; Second place winner \$1,000; Third place winner \$750; Fourth and fifth place \$250.

Essay Focus

Essays must focus on the future—the next decade, specifically. The question is how best to move the objectives of UNSCR 1325 and the WPS agenda forward in the 2020s, given the successes and failures of the last two decades.

Essays must contain specific and practical (realistic) recommendations for civil society, states, and/or international organizations.

Essays can focus on only one international actor (e.g. civil society, a particular state or group of states, the United Nations, a regional organization) or on a multitude of international actors.

Essay Eligibility

Essay submissions are open to young professionals with an MA or higher academic degree, and students currently enrolled in a MA, PhD, JD or corresponding graduate program at a university or equivalent academic institution in 2020. Recent graduates, as well as individuals who will be enrolled in a graduate program within the next academic year, will also be considered. All genders are encouraged to apply.

Essay Requirements

Essays must be the individuals' own original pieces of work, not previously published; Essays must be written in the English language and be between 1,500 and 2,000 words; Submissions must also include: (1) a 250-word summary; (2) a bibliography; (3) a brief biography; and (4) a copy of school/university enrollment; Optional – a photo.

The biography should include: a) full name of student; b) name of the school or university and program in which the student is enrolled; c) student contact information (email and phone number)

The summary, bibliography, and biography do not count toward the maximum word count of 2,000 words;

Citations should be included as endnotes and follow the Chicago Manual of Style;

Essays must be typed (single spaced) in 12-point Times New Roman and submitted in both Word and PDF format;

Essays and other submission requirements must be submitted by April 15th 2020 at midnight EST to the online submission form.

Evaluation Criteria

An international jury of scholars and practitioners will evaluate the essays. Essays will be judged on clarity and clear elaboration of arguments as well as the innovative and original nature of policy-recommendations. Winners will be announced on June 30th 2020.

What Does the Coronavirus Pandemic Teach us about Democracy and Authoritarianism

The Coronavirus pandemic has rocked our world. 30,000 people have been killed (10,000 in Italy alone) and the number of known infections is approaching 1 million. The global economy is facing a recession, international travel has come to a standstill, millions of people have lost their jobs and most governments have ordered their citizens to stay at home. International attention is now exclusively focused on this expanding crisis, which most experts believe is still in its early phase with the worst yet to come.

This pandemic raises many important questions. How did we get to this moment of crisis? Why was the world so colossally unprepared? Are some governments more to blame than others for the spread of this virus and critically, are democracies better equipped than authoritarian regimes in meeting the challenges of a pandemic?

Nader Hashemi, Director of the Center for Middle East Studies at the University of Denver's Josef Korbel School of International Studies will discuss this topic, with special attention to how Muslim societies have been affected by this crisis. He will also answer your questions.

About the Author

Nader Hashemi is the Director of the Center for Middle East Studies and an Associate Professor of Middle East and Islamic Politics at the Josef Korbel School of International Studies at the University of Denver. He obtained his doctorate from the Department of Political Science at the University of Toronto and previously was an Andrew W. Mellon Postdoctoral Fellow at Northwestern University and a Visiting Assistant Professor at the UCLA Global Institute. His intellectual and research interests lie at the intersection of comparative politics and political theory, in particular debates on religion and democracy, secularism and its discontents, Middle East and Islamic politics, democratic and human rights struggles in non-Western societies and

The Caravan: Abdallah Azzam and the Rise of Global Jihad

Abdallah Azzam, the Palestinian cleric who led the mobilization of Arab fighters to Afghanistan in the 1980s, played a crucial role in the internationalization of the jihadi movement. Killed in mysterious circumstances in 1989 in Peshawar, Pakistan, he remains one of the most influential jihadi ideologues of all time.

Here, in the first in-depth biography of Azzam, Thomas Hegghammer explains how Azzam came to play this role and why jihadism went global at this particular time. It traces Azzam's extraordinary life journey from a West Bank village to the battlefields of Afghanistan, telling the story of a man who knew all the leading Islamists of his time and frequented presidents, CIA agents, and Cat Stevens the pop star. It is, however, also a story of displacement, exclusion, and repression that suggests that jihadism went global for fundamentally local reasons.

Fighting COVID-19: Experiences and lessons from the frontlines in Asia

Since the outbreak of COVID-19, East Asian nations have worked to control the spread of the disease through coordinated public-health responses on scales not seen since the 2002-03 SARS outbreak. China, Japan, Singapore, and South Korea have each employed policy tools such as focusing on early diagnosis, encouraging the use of personal protective equipment (PPE), limiting travel, instituting lockdowns, and aggressively monitoring infections to slow the spread of the virus within their countries. As the United States hones its response, Asian experts have experience and lessons to share from their responses to fight the disease across the Pacific. What has made this outbreak so different from the SARS, MERS, Ebola epidemics, and other flus? What has worked well for each country, and what hasn't? How should the U.S. prepare for what's to come during the outbreak and in its aftermath? Is a more unified global response needed, and if so, what would it look like?

On April 3, the Brookings John L. Thornton China Center will convene a webinar featuring experts from Asia who will address these questions and discuss what has worked to combat this pandemic. Brookings President John R. Allen will offer opening remarks, followed by two panels — one reviewing country responses and the other assessing trajectory and treatments of COVID-19. Following the conversation, panelists will take questions from the audience.

Launch of Report on Decision-Making on Belt and Road Projects: What Role for Sustainability?

Chinese overseas investment associated with the Belt and Road Initiative (BRI) has predominantly flowed into fossil fuels and other forms of high-carbon infrastructure across the developing countries. While a growing number of voluntary standards and networks seek to “green” the BRI, it is not yet clear how these will influence the decisions and incentives of key actors in China and recipient countries developing BRI-related projects. A new report from ISEP at Johns Hopkins University, the Blavatnik School of Government at the University of Oxford, and the ClimateWorks Foundation seeks to better understand how sustainability considerations do and do not enter into decision-making around BRI projects. The report is based on in-depth elite interviews with regulatory agencies, policy banks, NGOs, and state-owned enterprises in China, and seeks to unpack BRI’s decision-making processes by revealing divergent preferences, incentives, and bureaucratic capacity of various related actors. Policy recommendations on how to green the BRI are made based on these findings. The webinar will present the report’s key findings and provide a forum to discuss their implications with key stakeholders.
