Authoritarian powers like China and Russia are covertly financing political actors to undermine democracies. Three momentous developments -- the rise of China, collapse of the USSR, and enlargement of the EU -- accelerated the economic interdependence of Eurasia at the turn of the twenty-first century, according to Kent Calder, author of *Super Continent: The Logic of Eurasian Integration*, Stanford University Press, 2019.

COVID-19 has now jolted the world's largest land mass. The pandemic created an unprecedented global economic shock as borders closed, supply chains fragmented, and

protectionist barriers rose. The long-term impacts are uncertain. However, business as usual is unlikely to mark the new normal.

The Growing Political Power of Women of Color

The Center for Women in Politics and Public Policy is a program of TWU's Jane Nelson Institute for Women's Leadership. The JNWL is dedicated to preparing women to take on successful roles in business and public service to ensure women have the education to establish careers as successful C-suite executives, the skills for building entrepreneurial businesses and the framework needed to run for public office.

Increased attention has been drawn to the growing political power of women of color in the United States. This is in part due to their significant strides at attaining electoral office. Beyond office holding, political participation rates for women of color have also increased dramatically, exceeding increases for their male counterparts. As a result, women of color are poised to dramatically influence American politics by gaining more political authority and voting power.

Christina Bejarano, Ph.D., is a nationally recognized author, speaker, and advisor on Latina electoral politics in the U.S. She studies the conditions under which racial/ethnic minorities and women successfully compete for U.S. electoral office, which is reflected in her book on Latina political candidates--*The Latina Advantage: Gender, Race, and Political Success* (University of Texas Press, 2013). Her work also focuses on how racial/ethnic minorities and women can shape or influence the current electoral environment, which is reflected in her second book--*The Latino Gender Gap in U.S. Politics* (Routledge Press, 2014).

Bejarano has given talks to various campaign and leadership training programs to share her research on Latina politics. She served as a guest expert analyst for Presidential Gender Watch in 2016 and Gender Watch in the 2018 election, helping to track and analyze the gender dynamics in both elections. Bejarano also served on the national advisory council for LatinasRepresent, a joint initiative working to increase Latina political leadership and representation.

This report builds on the global WPS Index, launched in 2017 and updated in 2019, that evaluates women's status and well-being across 167 countries around the world. US-Venezuela Defense Relations

On Friday, October 8 at 2:00 p.m. ET, William J. Perry Center for Hemispheric Defense Studies Assistant Professor Dr. Fabiana Perera will provide a virtual talk on “US-Venezuela Defense Relations.”

Venezuela is the only country in Latin America that was ever able to purchase F-16s from the United States. The purchase of the aircraft is a clear indicator of the strength of the defense relationship between the two countries in 1980's and 1990's. Since then the relationship has deteriorated considerably, allowing space for extraregional actors to play increasingly important roles in the security and defense sector of one of the region's largest oil producers. This talk will examine the defense relationship between the United States and Venezuela in the period from the Cold War to the present. It will highlight key inflection points in this relationship and challenges to be addressed in the event of a transition to democracy.

Fabiana Sofia Perera is an Assistant Professor at the William J. Perry Center for Hemispheric Defense Studies. Prior to joining the Perry Center, Fabiana was a Rosenthal Fellow at the Office of the Secretary of Defense, Under Secretary for Policy, Western Hemisphere Affairs. Fabiana has experience working in the public and private sectors including at the Department of Veterans Affairs, and USAID. Fabiana holds an MA in Latin American Studies from Georgetown University and earned a PhD in Political Science from The George Washington University. For her doctorate, Fabiana completed fieldwork in Venezuela and Ecuador. Her research and analysis have appeared in numerous publications including *The Washington Post*, *CNN.com*, and *War on the Rocks*.

The official celebration of NATO's 70th anniversary past December was not marked by business as usual. Are we on the same wavelength? EU terminology used in Slovak media and its potential to reach out to more citizens

Date: March 11th, 2021

Based on the success of previous editions, this year again the TEW will be organised in close cooperation with Saint Jerome Days taking place at Comenius University on 15 and 16 October 2020 (Saint Jerome Days are organised by the Slovak Association of Interpreters and Translators and bring speakers from the translation industry to discuss burning issues of translators' reality with graduate students and freelancers).

Diverse stakeholders in the audience will have an opportunity to learn and reflect on EU terminology and localisation of EU texts in the public domain, e.g. where and how it is created ('Brussels' or Slovakia?) and how media work with it in the rapid media environment. Last year's turnout at EU election in Slovakia (twice as high as at the previous elections but still the lowest across EU), serves as a proof of media's important role in building up the positive image of EU among Slovaks. The target audience of this one-day-event will be: journalists, media experts, freelancers, EU translators, academia, terminologists, linguists, translation students

- Translating and localising EC press release;
- Translating EU news for Slovak media (speaker from the News Agency of the Slovak Republic);
- EU communication with the media (Peter Stano, Lead Spokesperson for foreign affairs and security policy in VP/High Representative Josep Borell Fontellesteam);
- Terminology presentation on cybersecurity (JUDr. René Baran, National Security Authority);
- Reflection of EU terminology in media –what are the pitfalls?;
- Language used in/by the media (round table discussions in small groups)
